Updated Syllabus

Information Literacy Assignment:

Prepare an annotated bibliography of research articles or other relevant sources on medical marijuana as an effective treatment for at least three of the following diseases and conditions: Cancer, Epilepsy (Seizures), Arthritis, Psoriatic arthritis, Multiple Sclerosis, Alzheimer's, Migraines, AIDS (HIV), and Psychological conditions.

You should use at least 2 journal articles to find the information of each of the diseases selected. Mr. Velappan (FSU: Librarian) will work with you by teaching how to find the library resources. You will find more information about information

Literacy assignment and Learning material in Canvas "information Literacy folder". Also, I have created a discussion forum for information literacy assignment and Mr. Velappan will answer any of your questions.

Your writing should be about three pages. It should include the followings:

- Annotated bibliography of each of the three diseases.
- What conclusions can you draw from these articles? Medical marijuana as an effective treatment for the diseases/conditions you selected.
- Bibliographical references for all the journal articles used it should be APA citation format.

Annotated bibliography

Abrams, D. I. (2016). Using Medical Cannabis in an Oncology Practice. *Oncology* (Williston Park, N.Y.), 30(5), 397-404.

The author, Donald I. Abrams is a cancer and integrative medicine specialist at the UCSF Osher Center for Integrative Medicine at Mount Zion. In his review, Abrams discusses the importance of prescribing medical marijuana to his patients. He uses longitudinal data to support his claim that medical marijuana decreases nausea, anorexia, insomnia, depression, and pain associated with cancer. He argues that medical marijuana is a much safer alternative than prescribing multiple medications that can interact with one another, to treat the symptoms associated with cancer and cancer treatment. The results indicated that medical marijuana is a safe alternative to treat cancer patient's nausea, anorexia, insomnia, depression, and pain. Similar to the findings this article, Joan Kramer found that medical marijuana reduces pain sensitivity and decreases nausea, vomiting, weight loss, and pain of patients undergoing chemotherapy.
